The Certified Medical Assistant[®] (AAMA)—or CMA (AAMA)—credential represents a medical assistant who has been credentialed through the Certifying Board (CB) of the American Association of Medical Assistants[®] (AAMA).

Postsecondary Medical Assisting Education Required



- ✓ Must be a graduate who has completed at least two semesters, or the equivalent.
- ✓ Must include basic anatomy, physiology, pharmacology, and relevant mathematics. (*Review the [Content Outline for the CMA \(AAMA\) Certification Exam](#) for more details.*)
- ✓ Must verify theory and techniques for venipuncture as well as intramuscular, subcutaneous, and intradermal injections. (*Review the [Content Outline for the CMA \(AAMA\) Certification Exam](#) for more details.*)

Credential Violations

A medical assistant who does not hold a medical assisting credential, who holds a credential other than the CMA (AAMA), or whose CMA (AAMA) is not current is not permitted to use these initialisms or this phrase:

- CMA (AAMA)[®]
- CMA^{CM}
- Certified Medical Assistant[®]
