Deadline

Entries must be emailed or postmarked by **July 15, 2024.**

Submissions

To nominate someone for any of the categories, you must submit the following:

1. Completed entry form
2. A detailed statement listing specific accomplishments achieved by the nominee*
3. The nominee’s professional résumé, which includes work experience*
4. The nominee’s AAMA résumé, including involvement at all three levels of AAMA membership, current CMA (AAMA) status, and emphasis on national achievements*
5. At least two detailed letters of recommendation supporting the nominee’s qualifications for the select award (*Word docs are preferred, but PDFs will be accepted.*)
6. A headshot of the nominee that the AAMA may use in the awards announcements

Note: All submitted materials are subject to future use as marketing materials and the like by the AAMA. Such materials may include photos, quotes, and even a recorded acceptance speech (if applicable). By submitting an entry form to the AAMA, you agree to permit the AAMA to use these materials at the AAMA’s discretion.

Email entries: Type the state or nominee name into the subject line. Attach this completed form and all required submission materials and send to MarCom@aama-ntl.org.

Eligibility

Submitters must be AAMA members. Nominees must be AAMA members and CMAs (AAMA).

Distinction winners can only win a particular award once, but they can be nominated for a different Distinction Award after three years. Currently serving Board of Trustees members cannot be nominated. But selection will favor those who have served on the national level.
