SUPPLEMENTAL REPORT OF THE BOARD OF TRUSTEES

- The chairs of the Certifying Board and Continuing Education Board were given the opportunity to provide updates.

- AAMA CEO Donald Balasa reported on New York legislation, Texas legislation, and the IV initiation RFP.
- Votes taken since the submission of the Delegates Packet reports:
 - Approved request for the Leadership Development Strategy Team for State Leaders project.
 - Approved CEB volunteer appointment.
 - Approved a 10 % discount for members on CEU products and seasonal sales.
 - Approved request of the Awards committee.
 - Approved Michael Knight to begin the upgrade to Aptify to allow the PayPal integration.
 - Approved the renaming of the Social Media Committee to the Engagement and Outreach Committee.
 - Approved some appointments to the BOT committees, strategy teams, and task forces for 2025-2026.
- The membership numbers as of the end of August 2024 were 22,786 and as of August 2025 are 20,034. This is a decrease of -12%.

ARTICLE IX—NOMINATIONS AND ELECTIONS
